f. The managing Trustee shall act on behalf of the trustee and be in the management of all the powers of the board of trustees , he/she may delegate further power to his/her Secretary.



(c) Trust at its Annual Meeting shall consider and approve the annual Accounts of the previous year, budget proposals, annual report on the activities of the Trust and also matters brought up by any Trustees.


- 1. Trustee shall forfeit his Trusteeship of the Trust.
